On 10/11/81, fifteen year-old Robin Walker from Cincinnati, OH, reported that she and her friend, Marie Patrick (age 15), were in the process of running away from home to Texas.



While hitchhiking, they were picked up by a truck driver in Cincinnati. While on I-64 at the 67 MM, the truck driver known as "Bill" attempted to fondle Marie as she was lying in the sleeper of the cab. Marie got out of the sleeper and sat next to Robin. Bill attempted to fondle Marie again. Marie told Robin to jump from the truck. Marie opened the door and jumped out of the moving truck. Robin also jumped. Marie's body was found the next morning. She died of a fractured skull.
