Forum planned for C-P

Hundreds more students are expected and several new schools are planned for Clark-Pleasant schools in the next decade.

Parents and taxpayers in the district can get an update on construction projects and find out how the district is planning to deal with rapid enrollment growth at a public forum Thursday.

The school's long-range planning committee will tell community members how many more students are expected in coming years, what programs are needed to teach students and what facilities will be required.

Clark-Pleasant Community School Corp., the seventh-fastest growing school district in the state, is expected to add at least 300 students a year to its enrollment for the next several years.

But administrators said that number could be higher. This fall, the district opened its doors to about 500 new students who weren't enrolled in May.

The district has recently finished additions to two elementary schools and the high school and opened a new intermediate school.

Two new schools are expected to open by 2009.

After that, officials are planning for more additions to the high school and middle school.

Another forum is planned for May, school officials said.

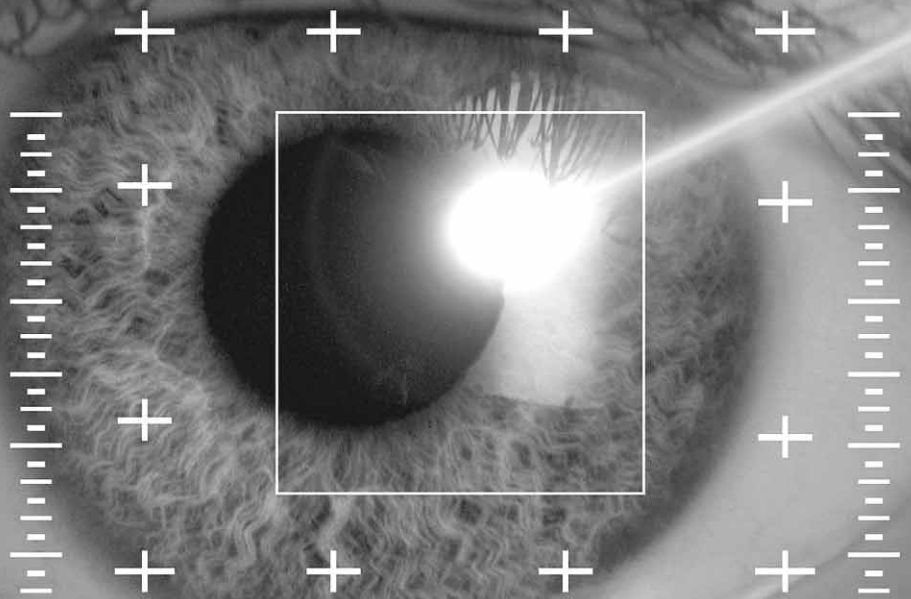
