## Cracking under dry weather

### Limiting long baths, lathering on lotion helps to save Hoosiers' skin

If you find yourself with a constant itch or cracked skin this winter, you're not alone.

Cold air outside and heated air inside sap skin of natural moisture, as there's less humidity in the air.

Furnace heat or bathing too frequently can leave skin even drier.

Employees at area beauty shops and salons said residents are visiting their businesses complaining of itchy, dry skin and looking for the best products to treat it.

The number of people searching for relief usually jumps in the winter, partly because more people have dry, heated air running in their homes, said Emily Schnell, an aesthetician at Pure Ambiance in Greenwood.

The skin-care specialist said she hasn't had too many people asking for help this year since central Indiana has had a relatively mild winter.

Still, Schnell and other aestheticians agree that dry skin

#### Tips for treating dry skin

Itching to soothe suffering skin? Keep these hints in mind:

- Avoid taking really hot showers, which strip oil off the skin. Keep baths and showers short.
- Use as little soap as possible. Use gentle cleansers, such as Cetaphil or Aveeno, or soaps that have glycerin in them.
- Dry your skin thoroughly but gently. Pat, don't rub.
- Find a moisturizer that works best for you. Avoid products with alcohol. Apply just after a bath or shower, when

your skin is still damp.

• Lotions that have lactic acid or glycolic acid can help dissolve the layer of dry skin. Cetaphil and Eucerin have these ingredients.

• Baby oil can be a good moisturizer for people with moderately dry skin.

• Omega 3 fatty acid foods and supplements, like concentrated fish oil pills, help put oil back into the skin.

People can have different types of dry skin, said Donna Alexander, an aesthetician at Design Lines Salon Spa in Greenwood.

Alexander said they give personal consultations with area residents to try to find the primary cause of the winter itch.

Medications, environment, health problems and diet can all contribute to the problem, Alexander said.

Area residents had their preferred method of battling the winter itch.

Lathering up with lotion is a common defense.

Nineveh resident Melissa Hannebaum said she had to start applying lotion recently to keep her face from peeling.

Julie Wells, co-owner of Imagination Station in downtown Franklin, found products made by Arbonne International kept her skin from getting dry skin this winter.

### Man convicted of 2002 burglary found dead

A Hope resident who pleaded guilty to burglary in Johnson County was found fatally shot Monday in his car in Indianapolis.

Frank Fantozzi, 42, was found at 3639 Nobscott Court in Indianapolis about 11:30 p.m., according to an Indianapolis Police Department report.

Fantozzi lived on Seminary Street in Hope.

He pleaded guilty in June 2002 to burglary in Johnson County and was sentenced to 3½ years in prison, according to court records. He was accused of breaking into a Greenwood Dog 'n' Suds restaurant.

He told police he committed the crime after a 1½-day cocaine binge because he was angry that his wife had been fired two weeks earlier, the story quoted a probable cause affidavit as saying.

Fantozzi had been manager of the Crawfordsville and Greenwood restaurants.

Police said he was sitting in the driver's seat of his car with a gunshot wound to his chest. Fantozzi was transported to Methodist Hospital in Indianapolis and was pronounced dead just before midnight.

Police said they had no immediate motives or suspects in the case.

### Candle deemed cause of fire; no one hurt

A blaze started by an unattended candle caused about \$20,000 in damage to a Greenwood home.

Residents of a house at 249 Greenwood St. were not inside when the fire started, said Lt. Tom Kite, spokesman for the Greenwood Fire Department.

A burning candle inside the living room ignited curtains and furniture. Firefighters spent about an hour putting out the

blaze. No one was injured, Kite said.

The blaze mainly burned the living room and caused smoke damage inside the home, he said.

A renter of the home, Sheila Pearson, was in the backyard when the fire started about 4:30 p.m. Thursday.

Pearson rents the home from owners Jim and Rhonda Young.

Residents won't be able to return to the house until the smoke and fire damage is repaired, Kite said.

### Woman subdued after kicking, hitting officer

A Franklin woman arrested on drug charges Friday would not agree to cooperate with police unless they gave her a cigarette.

The woman was on the ground and refused to stand. A sheriff's deputy reached down to pull her up, and she kicked him in the thighs and between the legs, police reports said.

She elbowed the officer in the throat before he pressed a Taser against her back to subdue her, police reports said.

Samantha Marrie Suppers, 22, Franklin, was arrested on charges of prescription drug fraud, resisting an officer, possession of controlled substances and two charges of battery.

Sheriff's deputies went to 2025 Franklin Cove, Apt. 2 for a probation check. Officers found hydrocodone pills and Toradol, a prescription anti-inflammatory medicine, in Marlboro cigarette packs, police reports said.

Suppers admitted she did not have a prescription for the medicine, according to police reports. Sheriff's deputies also found a marijuana pipe in the apartment.

Suppers was being held in Johnson County jail Tuesday on \$40,000 bond.

##### Plan commission

On Monday, the commission:

- Approved 9-0 to continue discussion about Cobblestone Estates, a 176-lot development on 95 acres at Honey Creek Road between Stones Crossing and Demaree roads. Members plan to discuss the development at their meeting next month.

- Approved 9-0 continuing the discussion of McCarty Farms, a development planned to include 20 businesses and 700 homes on 237 acres near the intersection of State Road 37 and Olive Branch Road. Members plan to discuss the development at their meeting in April.

- Discussed changes to zoning rules in the county, which would include changing the zoning of floodplain areas to agricultural. It would also cut out requirements of planned unit developments in the county's ordinance, allowing the plan commission to decide requirements for each development. The discussion will be continued at next month's meeting.
