Big-ticket items stolen from Center Grove area homes last

week have been found. A \$150,000 car was parked inside a rental home garage in Indianapolis, a Johnson County Sheriff's Office affidavit said.

Two big-screen TVs, a computer and clothes were found in a home at Friendly Village Trailer Park in the Center Grove area.

One man is in jail. Brian K. Wynne 42, 40 S. Alabama St., Indianapolis, was arrested on charges of burglary, theft and residential entry. He was being held in the Johnson County jail on \$98,000 bond.

Wynne told officers he was measuring homes for carpet installation while on work release in Marion County, accord- Chief Deputy Doug Cox said. ing to a police report.

Police arrested him after a resident on Highland Park Drive heard someone breaking into her home Friday, the report said. The victim told police she saw a van speed away from her home, and sheriff's deputies stopped Wynne driving away from the home, the report said.

Footprints inside the victim's home matched boots worn by Wynne, according to the report.

The recovered items were found in the home of a woman who was with Wynne when he was arrested, a police affidavit said. The woman cooperated with detectives and told them where to find the stolen items.

Most of the items stolen from the two homes on Eagle Trace **Drive and Berkshire South Drive** have been found, sheriff's office A stolen gun is still missing, he

said. A computer, NASCAR jackets, jewelry and a child's bicycle were stolen from the house on Berkshire South Drive on Wednesday, according to the report.

Johnson County sheriff's detectives found three TVs stolen from the Eagle Trace Drive home and four other TVs believed to be stolen, the report said.

A set of gold golf clubs, jewelry and a drawer from an antique dining buffet stolen from a house on Eagle Trace Drive were found in the trailer, the affidavit said.

No other arrests have been made. Cox said. Detectives are interviewing other people who may have participated in discussions to burglarize the homes, he

Flooding closes county roads this month, Franklin has record-

Residents who use county roads to get to work might need to find an alternate route this morning.

The Johnson County Highway Department closed several county roads due to flooding, especially from Sugar Creek.

The following roads were closed Monday and will remain closed at least through this morning:

• County Road 350S west of U.S. 31 at Amity • County Road 250S west of

U.S. 31, southeast of Franklin Greensburg Road from County Road 700E to County Road 800E,

southeast of Franklin • County Road 400S east and

west of U.S. 31, south of Amity • County Road 725E north of County Road 400S, north of Edinburgh

• County Road 200N near County Road 75W, northwest of Franklin

County workers will check roadways this morning to determine when to reopen them, Johnson County Highway Department director Gary Vandegriff said.

In addition to the closed roads. warnings signs about high water are posted on nearly a dozen other roads. The standing water in the road-

ways likely will freeze overnight, said Angela Buchman, WISH-Channel 8 meteorologist. Temperatures should be in the upper teens to low 20s overnight, she said.

The National Weather Service issued a small-stream flood advisory Monday for rapid stream rises in Johnson County. Minor flooding of creeks and streams can be expected, the advisory said.

The county received nearly 1.5 inches of rain Sunday night and into Monday morning, which added to the already wet ground in the area. Most of the area has received between 2 and 4 inches during the past four days. So far ed 4.84 inches of rain. The rain is gone, but snow and

poor roadways will take its place. The flooding that was left behind by the four days of rain will be a concern for most of the week, Buchman said. There is a slight chance of snow this morning. Although there will be little or

no snow accumulation, even a few flakes could make roadways slick, she said.
