CG tech director leaving district

The person who oversees the computer systems and technology used by students and teachers at Center Grove is leaving.

Current technology director Jim Barney is resigning after 10 years with the district.

A committee is being formed to find his replacement. The interim superintendent said he hopes to have the job filled by mid-March.

Barney will take a position as executive director for administrative services with Ivy Tech Community College in downtown Indianapolis. His final day at Center Grove is Feb. 19.

As director, Barney oversees the day-to-day maintenance of all network systems at Center Grove, evaluates software and programs and makes recommen-

dations for upgrades. He is paid \$84,909 per year.

He also oversees a staff of eight people who repair and maintain all technology, software and hardware.

A committee of administrators and members of the public who are well-versed in technology is being formed, interim superintendent John Coomer said. The group will be asked to create a list of qualities, which will make up the job description for the position, he said.

The technology director is charged with deciding which upgrades and new programs are right for the district. Software selected by the individual will be used by thousands of students and hundreds of teachers at Center Grove.

"In this day and age of new technology, it is becoming an increasingly more important position," Coomer said.

A Greenfield man wore a bulletproof vest, badge and gun belt into an apartment office to try to convince workers he was a police officer, an arrest warrant affidavit said.

Matthew David Parker, 25, was arrested and charged with impersonating a public servant. The incident happened Dec. 4, and Parker turned himself in Wednesday.

Parker, of 18 N. State St., went to Bexley Village Apartments dressed as a police officer, with black pants and a leather jacket, to find out the address of a resident, the affidavit said.

He told an office manager he was an officer with the car

crimes unit and the resident was not in trouble, but he needed the person's address so he could testify, the affidavit said.

Parker left when the apartment manager asked for identification or paperwork to prove Parker needed the address, the affidavit said.

The manager called police and gave them Parker's description and license plate number. He was driving a former sheriff's car, the affidavit said.

Greenwood police stopped Parker the day of the incident. He told police he was at the apartment complex's office but did not tell workers he was a police officer, the affidavit said.

Parker was released Wednesday from the Johnson County jail on \$3,000 bond.
